Model: Type 4 inch EQUATE pressure/vacuum relief valve (PVRV). Weight-loaded, constructed of 300 series stainless steel.

Pressure setting: 1.0 - 6.0 psig

Vacuum setting: 0.5 - 3.0 psig

The PVRV is designed and constructed to ERL drawing number 308K105B dated February 26, 2001.

The flow data on the PRVRV was carried out in CEESI Certificates of Calibration dated November 15, 2001 (1.0 and 1.5 psig pressure), January 22, 2002 (0.5 psig vacuum), January 23, 2002 (2.0 psig pressure), January 30, 2006 (2.0 psig pressure), February 10, 2006 (6.0 psig pressure), and February 14, 2011 (3.0 psig).

The PVRV valve has been tested in accordance with API 2000 and is approved for use in vapor control systems.

PVRV for use on U.S. flagged vessels shall be marked in accordance with 46 CFR 162.017-5.

The approval is subject to any conditions noted on this Certificate and in the applicable laws and regulations governing the use of the item on vessels subject to Coast Guard inspection or on other vessels and boats.

Consideration will be given to an extension of this approval provided application is made 3 months prior to the expiration date of this Certificate.

The approval holder is responsible for making sure that the required inspections or tests of materials or devices covered by this approval are carried out during production as prescribed in the applicable regulations.

The approval of the item covered by this certificate is valid only so long as the item is manufactured in conformance with the details of the approved drawings, specifications, or other data referred to. No modification in the approved design, construction, or materials is to be adopted until the modification has been presented for consideration by the Commandant and confirmation received that the proposed alteration is acceptable.
